

BROKER REGISTRATION AGREEMENT

Broker participation is welcomed. You must be a licensed Texas Real Estate broker and complete this form.

A referral fee of 2% of the high bid price will be paid to the licensed Texas real estate broker whose prospect pays and closes on the property. To qualify for a referral fee, the real estate broker must:

- (a) be a licensed Texas real estate broker
- (b) first register the prospect by completing this form and returning it by email to lrichardson@tranzon.com or by fax to 817.391.1723, no later than October 5, 2015 at 4:00 PM CT. This registration form must be (1) signed by the prospect and (2) be received before any inspection of the property by the prospect;
- (c) assist the bidder with due diligence and online bidding, if necessary.

Each agent must bring a copy of his registration to the auction and submit a copy of the form when their prospect registers for the auction. A complete registration file on all prospects will be maintained. No broker will be recognized on a prospect who has previously contacted or been contacted by the Sellers or their representatives. Referral fees will only be paid upon closing and receipt of commissions. No referral fees will be paid if the agent or a member of his immediate family is participating in the purchase of the property and an affidavit may be required that the agent is serving only as broker and not as a principal.

It is understood and agreed that if for any reason whatsoever the sale is not finally closed, including acts, omissions, or negligence on the part of the Seller and/or Auctioneer, Auctioneer and Seller are relieved from any and all liability, claim or charge whatsoever, and no referral fee or other compensation shall be due or payable. If Buyer defaults under the Purchase Agreement and the deposit is forfeited by Buyer (as defined in the Purchase Agreement), or any portion thereof, or Buyer pays or becomes liable for damages to Seller, I shall not be entitled to any portion of such forfeited deposit(s) or damages. In the event a commission reduction is required to consummate a sale, registered broker's commission may be reduced proportionately. Only one broker will be paid on the transaction; if winning bidder has signed the registration form with more than one broker, all parties will be disqualified from earning the commission.

NO EXCEPTIONS TO THE ABOVE REGISTRATION PROCEDURE WILL BE MADE.
