FULL GOLF MEMBERSHIP

For the avid golfer, the choice is easy! As a Full Golf Member you and your family have full access to all 27 Holes (Meadow, Pine & Cypress). In addition, Full Golf Members also have access to all Club amenities including Tennis, Aquatics, Fitness Center, and Clubhouse privileges.

TIER 1

INITIATION FEE (DUE WITH APPLICATION): \$10,000

CURRENT DUES (BILLED MONTHLY): \$335 This is a discounted dues rate, lasting for 3 years. While the dues rate may adjust, the discount (\$144) will remain the same.

TIER 2

INITIATION FEE (DUE WITH APPLICATION): \$6,000

CURRENT DUES (BILLED MONTHLY): \$479

TIER 2

INITIATION FEE (DUE WITH APPLICATION): \$6,000

TENNIS MEMBERSHIP

INITIATION FEE (DUE WITH APPLICATION): \$1,900

CURRENT DUES (BILLED MONTHLY): \$215
