First, we would remove the old roofing. If necessary the wood deck would be re-nailed to meet current building code. We would then apply on Two (2) Owens Corning Re-Enforced fiberglass felt as a base sheet doubled lapped. We will install all new 6" white metal eave drip. We will apply a 36" self sealing valley material, a self sealing, starter roll. We will use six 1-1/4" hot dipped nails per shingle, Owens Corning Supreme 25 Year 3-Tab bonded fiberglass shingles, Driftwood. We will install Three (3) off ridge vents and 2 plies of self sealing modified roofing on rear lower sloped section and in the low sloped valley this roof carries a five year warranty of good workmanship from the date of completion of the work from Bill Shields Roofing.
