

Register for a Tranzon Online Auction



Find your online auction.

Go to www.tranzon.com and click "Search Auctions." Or if you know the auction's Web ID, type it in the search box. Find the property you want to bid on in the list and click on it to go to the listing page.





Log in to tranzon.com.

When you get to the property listing page, you'll see this button underneath the main property image:

Now that you're logged in, the registration button on your auction's property listing page should look like this:



When you click "Register to Bid," you'll be asked to verify your personal information. You can update your information if you need to, or click "Continue - Info Correct" if nothing has changed.



Accept the Terms & Conditions.

On the next screen, you'll find the full Terms and Conditions for the auction. You should read over these carefully and contact the Tranzon office in charge of the auction if you have any questions before you continue. Once you're satisfied that you understand and agree to the auction's Terms and Conditions, simply click the "I AGREE" box, type your name in the signature field, then click "Agree and Continue."





Provide credit verification (if asked).

You may be asked for credit card information to securely verify your identity and eligibility to bid. Enter the requested information and click "Continue." You'll be contacted by a Tranzon representative by phone or e-mail when you've been approved to bid.

Credit Card Authorization: Frequently Asked Questions

You are being asked to provide a valid credit card account in connection with your registration to bid on this auction. "The identity of all bidders will be authenticated through the credit card information provided during registration". Please note the following general information concerning this credit card registration process:

Q: Does my card get charged?

A: No, but we put a "hold" on your card in a modest amount, typically \$1000. Important Note: We recommend using a credit card, not a debit card, as most credit card providers permit us to place a "hold" but not charge the credit card. Most debit cards will not recognize "hold" transaction, and may either reject it, thereby invalidating your registration, or pull the funds from the associated account.

Q: How long is the hold placed on my card?

A: If you are a successful bidder, the hold on your credit card will be removed within 24 hours after you have paid in full for the property or we have received any required earnest money deposit. If you are not the successful bidder, the hold will be removed within 24 hours after the end of the auction.

Q: Can I cancel the hold before the auction has ended?

A: No! Once you have registered as a bidder for the auction, the hold will remain in place until the auction has ended.

Q: Can I cancel the hold after the auction has ended if I am the winning bidder?

A: No! Once you are identified as the winning bidder, you have agreed to purchase the property. There is no rescission or "cooling off period" and the hold will remain on your credit card account until you have completed the purchase of the property or submitted any required earnest money deposit That is why it is important for you to conduct all of your due diligence and inspections prior to auction day and before you register for the auction and bid on the property. Please review the auction terms and conditions for further information.

Q: Will the amount of the hold be applied towards the final price payment?

A: No. If you are the winning bidder, you will be required to submit your earnest money deposit in full via wire transfer (or otherwise as agreed by you and Tranzon) immediately after you receive the purchase agreement. The hold on your credit card will be removed after you have paid in full for the property or we receive the required earnest money deposit.
